

# **NYC McKinney-Vento Workshop | December 2017**

## **Session Descriptions**

### **First Block of Sessions (9:15 – 11:00)**

#### **McKinney-Vento Overview (Room: Auditorium)**

Every school in New York City has someone assigned to the role of School-Based Liaison (SBL) to support students in temporary housing. This session will review the role of the School-Based Liaison and strategies for carrying out the Liaison responsibilities. Participants will learn about how to identify students experiencing homelessness, the core services available to such students under the McKinney-Vento Act, and best practices and creative strategies for supporting students experiencing homelessness. The session will focus on services and strategies for working with students in temporary housing in Middle and High Schools. Participants will develop an action plan during the session to help them implement what they've learned when they return to their school communities.

#### **Supporting College Access for Students Experiencing Homelessness (Room: C198)**

NOTE: First 30 minutes of this session will be a brief review of McKinney-Vento rights and services followed by the session topic described below.

The recent changes to the McKinney-Vento Act now require that school districts provide college counseling and college readiness supports for students experiencing homelessness. This session will provide strategies for how STH school-based liaisons can meet these new requirements and explore how to better support students experiencing homelessness in accessing higher education.

#### **Rights and Responsibilities of Unaccompanied Youth (Room: C202-203)**

NOTE: First 30 minutes of this session will be a brief review of McKinney-Vento rights and services followed by the session topic described below.

This presentation focuses on the rights and responsibilities of students who are temporarily housed without a parent or guardian. The presentation will discuss the meanings of "unaccompanied homeless youth" and "emancipated minor" and explain when those two categories overlap as well as the rights of young people in either category. Topics to be discussed include:

- when a youth may apply on his/her own for and receive public assistance benefits or Medicaid;
- when a minor may consent to health care;
- the rights of undocumented youth;
- leaving home without permission, foster care, and Person in Need of Supervision (PINS) cases; and
- financial aid for college for unaccompanied youth.

#### **Homelessness Prevention and Shelter Services for Families and Youth (Auditorium)**

In this panel presentation, speakers from Department of Homeless Services (DHS), Department of Youth and Community Development (DYCD), and the Human Resources Administration (HRA) will address:

- Eviction and homeless prevention services,
- Shelter and emergency housing services for families and youth,
- Public benefits available to families, and
- Services for survivors of domestic violence

The panelists will discuss the above points in the context of scenarios that school-based staff are likely to come across. After the session, participants will be better able to identify potential resources for families and youth and connect them with those resources. They will also have a better sense of how the City's three different shelter systems (for families, survivors of domestic violence, and runaway and homeless youth) operate.

Trauma can have a significant impact on a student's behavior in the classroom and overall academic performance. This interactive workshop considers approaches that school personnel can use in the building to work with students and families who have experienced recent or past trauma. Participants will gain better understanding of trauma, Adverse Child Experiences (ACEs), and how these affect the human brain and body. With this foundation, participants will practice various strengths-based strategies to manage student triggers using scenario role-plays. Participants will leave the workshop with tools to turn-key trauma-informed practices to other staff in schools and ways to self-reflect on their own triggers.
